If you, as the plaintiff, have decided to use a court officer to serve a Civil or Landlord -Tenant Summons and Complaint, Small Claims Affidavit or other document it is the plaintiff's responsibility to:

- 1. Select a court officer from the list (if you do not want to select one, ask the clerk to do a random selection for you by computer).
- 2. Contact the court officer by telephone.
- 3. Arrange to give the documents to the court officer.
- 4. Pay the required fees to the court officer.
- 5. Determine if service has been completed.
- 6. Contact the Court to ensure that your Proof of Service was filed with the Court in a timely manner**.

Please note the Court cannot give you any advice as to what method of service is best for your case or who to select as your court officer.
